Partnerships must comprise at least one early-stage business and one nonprofit partner implementing in one of P4G's ODA-eligible partner countries: Colombia, Ethiopia, Indonesia, Kenya, South Africa, and Vietnam. Applicants must provide services or products in one of the following sub-sectors: climate-smart agriculture, food loss and waste, water resilience, zero emission mobility and renewable energy. ## Sun Run - Sustainable Transport Africa

Sun Run - Sustainable Transport Africa is expanding its operations into Homabay county, Kenya. Sun Run conducted a data collection led by E-Safiri Charging Limited, speaking with 179 motorists and retailers to better understand the uptake of e-mobility within Mbita town and Kiumba Beach.

E-Safiri also signed an MOU with the Kiumba Beach Management Unit and the Awuoth Widows and Orphans Community Based Organization (CBO). The partnership will provide cold storage solutions for the fish vendors and a suite of e-mobility transport and cold storage solutions for the women. A new lease agreement

with the Awuoth Widows and Orphans CBO will also lead to the setup of a second charging hub in the area
